- 2. Eligibility criteria of the Chartered Accountant Firms for Statutory Audit are as follows:
 - Must belong to the Category I or II.
 - (ii) Must have 2 (two) or more numbers of Full Time Partners (FTPs) associated with the Firm for a period of at least 3 (three) years.
 - (iii) Out of total FTPs, 1 (one) or more Fellow Chartered Accountant (FCA) Partner associated with the Firm for a period of at least 3 (three) years.
 - (iv) Must have 1 (one) or more Full Time Partners / Paid CAs with CISA / ISA Oualification.
 - Must have 6 (six) or more years of Audit Experience of the Firm. (v)
 - Must have 8 (Eight) or more Professional staffs. (vi)

In addition to the above, the CA firms are advised to submit the declaration that "No adverse remarks / disciplinary actions has been taken in respect of professional conduct on the records of the Institute of Chartered Accountants of India (ICAI) and also by National Financial Reporting Authority (NFRA).
