The intending bidders are advised to inspect the Generator Set in the premises of the Baramba Branch Office at Baramba of the Banki Central Cooperative Bank Ltd. at Baramba on any working days during office hour between 11.00 a.m to.4.00 p.m. The bidders are required to deposit Earned Money as mentioned above in shape of cash or draft in favour of the Banki Central Cooperative Bank Ltd. at any branch office of the bank for the above purpose and to produce the challan copy in Head Office as prove of deposit of the same.
- 2. The auction sale price of the shall be decided on the basis of highest bid after final consideration of the Auction Sale Committee and the selected bidder who shall deposit 25% of the auction sale price on the same day and 75% of the auctioned sale price within 7 (seven) days to be considered to take delivery of the Generator Set.
- 3. If the selected bidder fails to deposit 25% of the auctioned sale price as per the terms & conditions mentioned above, his/her EMD shall stand forfeited and the offered to the 2nd selected bidder. The unsuccessful bidder shall get refund of their EMD on written request to the undersigned during banking hours on the working days.
